YOU MUST ATTEND DAY ONE OF THE SEMINAR IF YOU WISH TO ATTEND THE SCENT AND TRACKING WORKSHOP ON DAY TWO – no exception

SSCNC Provides a Continental style breakfast both days * A 70 MINUTE LUNCH BREAK EACH DAY (at Instructor's Discretion) will be given. There are plenty of restaurants within a mile or two of the facility and a spacious park across the street if you want to bring a picnic style lunch

DETAILS:

1. Participating Handlers under the age of 18 years must have a paid Auditor present at all times (Parent or Guardian)
2. Participants are asked to bring a dog that is leash broken, crate trained, fully inoculated and completely healthy on the day of this event. Puppies must be at least FOUR (4) MONTHS of age.
3. **FEAR BITING, DOG AGGRESSIVE DOGS, OR PEOPLE AGGRESSIVE DOGS are NOT PERMITTED.**
4. NO Bitches in Season may attend. .
5. NO SMOKING inside the building.
6. NO MOVIE FILMING, TAPING, or CELLULAR PHONES WITH CAMERA capabilities are permitted inside the clinic. Non flash still camera shots are OK.
7. All Pagers and Cellular Phones must be on vibrate or mute during training sessions

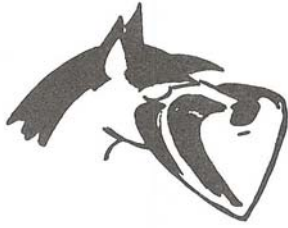
BRING:

1. A pan or bowl in which to water your dog
2. Bring LOTS of your dog's favorite treats in small pieces.
3. A SIX-Foot leather lead (3/8" or 1/4" wide) and a flat-linked chain or cloth collar; An appropriate-sized dog crate with bedding
4. Pencil, pens and paper for taking notes
5. Wear broken-in running shoes with tread, plus informal slacks and clothing

FOR SCENT AND TRACKING PARTICIPANTS

1. Bring a long line (10 feet or more) for the afternoon;
2. Bring a soft, well broken in harness (that your dog is used to wearing) – A Collar will also work for the novice dogs
3. Comfortable clothing and shoes (you will be on your feet for most of the day) that is appropriate for the weather of the day;
4. Chair to sit in during down times;
5. If you have a **CLEAN** pressurized spray (mister) water bottle (similar to those used in gardens for pesticide spraying) bring it with you loaded with water;
6. LOTS OF TREATS and your I-Clicker
